

Terms and Conditions – Your Kitchen Limited 25th Anniversary Promotion

- 1. Information on how to enter and prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
- 2. The promotion is open to New Zealand residents. Employees of the Promoter and any agency involved with this promotion, and the immediate families of such employees, are not eligible to enter. Immediate family includes the spouse, defacto spouse, child, parent or sibling.
- 3. The promotion commences on Monday 22 July 2024 and closes at Sunday 15 September 2024 ("Promotional Period").
- 4. To enter the promotion, during the promotional period the entrant must:
 - a. Place an order that is full price of \$15,000 including GST or over (excluding appliances)
 - b. Place their order with us during the promotional period as set out in 3 above.
 - c. Sign and return their quote and terms of trade or contract
 - d. Initial payment as per their quote (typically 50% of total).
- 5. Incomplete entries will be deemed invalid.
- 6. Orders made through companies are not eligible.
- 7. This is a one off-competition and there will be one winner drawn under third party supervision on Tuesday 17 September 2024.
- 8. Winners will be advised by phone call or email.

- 12. Once awarded, the Promoter is not liable for any part of the prize that has been lost, stolen, forged, damaged or tampered with in anyway.

entries, including but not limited to entries not received due to technical problems or human error. The time entries are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.

- 16. The Promoter may share entrant information, including name and contact details, with other persons or entities that assist in running the promotion.
- 17. The Promoter reserves the right, at any time, to verify the validity of entries and determine the eligibility of entrants (including an entrant's identity and age) and to disqualify an entry or refuse to award a prize where false or misleading details have been given by an entrant, or where an entrant has behaved in a fraudulent or dishonest manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.
